

Schell Product WARRANTY

The limited warranty covers factory defects in materials and workmanship for a period of 2 years subject to the conditions described below:

This limited warranty is provided to the original consumer owner only and not subsequent owners of the residence in which the product was originally installed.

The warranty starts from date of purchase from Larson.

Please register your product online at larson.co.za within 14 days of purchase to validate the warranty.

Not covered

The limited warranty does not extend to and expressly excludes:

- Losses or damages or the inability to utilise your Schell Product resulting from conditions beyond the Manufacturers control, including without limitation, accident, alteration, misuse, abuse, neglect, negligence, failure to install correctly, maintain, assemble or mount the Schell product in accordance with the Manufacturer's instructions or local plumbing codes.
- Wear-and-tear expected to occur during the normal course of use, including without limitation, rust, scratches, dents, chips or expected signs of use.
- Damage to the Schell product caused by blows, knocks, scratches or stains.
- Damage or discolouration to the Schell product caused by poor water quality, limescale or hard water.
- Damage to the Schell product caused by acids or harsh chemicals including but not limited to drain cleaners, bleaches or stain removers.
- Damage to the Schell product caused by corrosion or oxidation through contact with other materials.
- Damage to the Schell product fastenings caused by stored detergents and cleaning agents. (Do not store detergents and cleaning agents under your sink).
- Schell products installed in commercial applications, industrial applications, outside areas or open areas (areas without walls, windows and ceiling).
- Schell products installed in harsh environments for example boats, pool areas, braai areas or within 500 meters of the ocean.
- Noise or noise variation between units.
- Smells coming from Schell product.

Note:

A leaking Schell product due to incorrect installation, misuse, poor water quality, damage or abuse is not considered a factory defect and does not fall under the warranty cover.

No Other Express Warranty Applies

This limited warranty is the sole and exclusive warranty provided to the customer identified above. No other express warranty, written or verbal applies. No employee, agent, dealer or other person is authorised to alter this limited warranty or make any other warranty.

Larson or Schell will determine, in its sole and absolute discretion, if your Schell product is covered under this limited warranty.

If a covered claim is made during the warranty period, Larson will, through its authorized service representative, issue you a replacement Schell product. The replacement Schell product will be delivered free of charge to you provided it falls within 100kms of Ethekwini, Johannesburg, Port Elizabeth or Cape Town. Installation of the replacement Schell product will be for your own account. Replacement shall be determined by Larson in its sole discretion. If Larson determines that your Schell product must be replaced, the limited warranty on the replacement Schell product will be limited to the unexpired term remaining in the original warranty period.

Should the defective Schell product be out of stock or discontinued, Larson will offer a suitable alternative.

Limitation Of Liability

To the extent permitted by law, in no event shall Larson or its authorized service representatives be liable for any incidental, special, indirect or consequential damages, including any economic loss, whether resulting from non-performance, use, misuse or inability to use the Schell product or the manufacturer's or its authorized service representative's negligence. Larson and the manufacturer shall not be liable for damages caused by delay in performance and in no event, regardless of the form of claim or cause of action (whether based in contract, infringement, negligence, strict liability, other tort or otherwise) shall manufacturers liability to you exceed the price paid by the original owner for the Schell product.

The term 'consequential damages' shall include, but not be limited to, loss of anticipated profits, business interruption, loss of use or revenue, cost of capital or loss or damage to property or equipment.
